4. Details of our assessment

This Compliance Assessment Report (CAR) has been produced in response to the submission of annual performance report(s) and quarterly reporting required by the following environmental permit conditions.

Condition 4.2.2 of the environmental permit states:

A report or reports on the performance of the activities over the previous year shall be submitted to Natural Resources Wales by 31 January (or other date agreed in writing by Natural Resources Wales) each year. The report(s) shall include as a minimum:

(a) a review of the results of the monitoring and assessment carried out in accordance with the permit including an interpretive review of that data;

Condition 4.2.3 of the environmental permit states:

Within 28 days of the end of the reporting period the operator shall, unless otherwise agreed in writing by Natural Resources Wales, submit reports of the monitoring and assessment carried out in accordance with the conditions of this permit, as follows:

(a) in respect of the parameters and emission points specified in schedule 4 table S4.1;

(b) for the reporting periods specified in schedule 4 table S4.1 and using the forms specified in schedule 4 table S4.2; and

(c) giving the information from such results and assessments as may be required by the forms specified in those tables.

Reported emissions for quarter one and quarter three for copper at monitoring point TSP2 were outside of specified limits of Table S3.1 which represents non-compliance with the environmental permit.

Condition 3.1.2 has been breached due to the limits given in Table S3.1 being exceeded for copper.

The quarter one copper limit breach has been scored a C3 (minor) non-compliance based on its potential to have a minor or minimal impact or effect on the environment.

The quarter three copper limit breach has been scored a C3 (minor) non-compliance based on its potential to have a minor or minimal impact or effect on the environment.

An investigation was undertaken to determine the cause of the non-compliances. No incidents that could be attributed to the elevated results were identified.

ACTION: Operator shall submit to NRW a report detailing: all sources of copper on site, copper storage locations and storage methods, site drainage plan, and appropriate control measures you will implement to bring point source water emissions of copper within permitted limits.

Other than the above non-compliances for copper, all other reported point source emission to water for the period from 01/01/2024 to 31/12/2024 for emission points TSP 1 and TSP 2 were all within the permitted limits given in Table S3.1 which represents compliance with the environmental permit.
