4. Details of our assessment

This Compliance Assessment Report (CAR) has been issued in response to the annual monitoring return submissions 2024 (1 January - 31 December) by Dunbia (UK) (the operator) for activities at Cross Hands Business Park West, Cross Hands, Carmarthenshire SA14 6RF under environmental permit EPR-BU8002IT.

This compliance assessment was undertaken on 17 February 2025. However, to ensure that the CCS score is attributed to the correct financial year (for billing) the date on CARS has been altered to 31 December 2024.

Annual Monitoring Returns 2024

Permit condition 4.2.2 requires the operator to:

“A report or reports on the performance of the activities over the previous year shall be submitted to Natural Resources Wales by 31 January (or other date agreed in writing by Natural Resources Wales) each year. The report(s) shall include as a minimum:

- a. a review of the results of the monitoring and assessment carried out in accordance with the permit including an interpretive review of that data;*
- b. the annual production / treatment data set out in schedule 4 table S4.2; and*
- c. the performance parameters set out in schedule 4 table S4.3 using the forms specified in table S4.4 of that schedule.”*

A7 Emission Point

In December 2024, the operator notified NRW that the site has not conducted monitoring for its A7

emission point to air, as required annually in schedule 3(b) Table S3.1 of the permit.

In accordance with NRW's compliance scoring guidance, a non-compliance score of C3 has been recorded against sub-criteria IR3E.

Action

Ensure all monitoring requirements specified in permit condition 3.5.1 are conducted going forward.

Compliance Summary

- The annual monitoring return submissions were sent within the 2024 reporting period, which is **compliant** with permit condition 4.2.2.
- The monitoring return submissions for Q1, Q2, Q3, and Q4 in 2024 were made inside the respective reporting windows, which is **compliant** with permit condition 4.2.3.
- The monitoring returns submitted include reporting of monitoring carried out in respect of the parameters and emission points specified in table S4.1, S4.2, S4.3, and S4.4 of schedule 4, which is **compliant** with the environmental permit.
- The monitoring returns submitted are for the reporting periods specified in table S4.1 of schedule 4, which is **compliant** with the environmental permit.
- The monitoring returns have been submitted using the forms specified in table S4.4 of schedule 4, which is **compliant** with the environmental permit.
- The monitoring returns submitted include results and assessments as required by the forms specified in table S4.4 of schedule 4, which is **compliant** with the environmental permit.

Based on the reports submitted by the operator, all emissions at the monitoring points and permitted parameters appear compliant with the specified emission limits.
