4. Details of our assessment

Routine site inspection, intermittent rain with cloudy skies during the visit. Met with DCWW pollution tech onsite.

The system operates as a Combined Sewer Overflow with a return pump system to the sewer.

The rotating mechanical screen was seen while onsite. The screen was clear with only a small amount of screenings on the one side (photo 1). Please can you inform us when the last time the screen was cleared and inspected prior to the site inspection? Has the screen been inspected and cleaned since the site visit?

There is a second screen in the chamber (Photo 2). The screen was clear. How often is this screen cleaned? When was the last time it was cleaned and checked?

While onsite it appeared that the system has two spill points. Is this correct? There is only 1 EDM monitor onsite. If there are two spill points how is this being measured/monitored?

The emergency overflow screens were not blinded and the system appeared to be working correctly while onsite with flows being returned to the sewer.

There are onsite power generators for the system. How often are these maintained and tested? When was the last time they were tested?
