4. Details of our assessment

In this document 'Natural Resources Wales' means the Natural Resources Body for Wales established by Article 3 of the Natural Resources Body for Wales (Establishment) order 2012.

On the 05/12/2024 a Natural Resources Wales (NRW) officer carried out a routine unannounced inspection of the hydroelectric power (HEP) scheme on the Afon Iwrch at SJ

13449 26627, Trewern, Llanrhaeadr-ym-Mochnant, Oswestry, Powys.

The licence holder was not present during the inspection of the impoundment, but was later met at their farm. The visit was undertaken to assess compliance of the HEP scheme in relation the abstraction licence MD/054/0001/0062 and impoundment licence MD/054/0001/083.

The weather was showery, and there had been rain in the 24hrs preceding the inspection.

The fish easement/plunge pools appeared to be operating correctly, however high flows made it difficult to see the specific details of the structure.

The scheme was not abstracting due to a crack in the pipe between the abstraction point and the turbine house which has proven problematic to fix.
