3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

At this time, we do not intend to take any further action.

This statement does not stop us from taking additional enforcement action if further relevant information comes to light or offences continue.

4. Details of our assessment

This Compliance Assessment Report follows a prearranged inspection of the site on the 22nd January 2025. Officers met with the SHEQ Lead, SHEQ Advisor, Site Manager and Plant Manager.

Prior to the inspection a meeting was held with the Head of Operations and Sustainability & SHEQ Director.

CoTC cover is currently being provided by the SHEQ Lead with cover provided by other Tradebe staff as required. Two members of the site team are currently undertaking the CoTC qualification.

There has been a delay to the repair and re-concreting of the yard areas due to the weather. It has since been confirmed that this is scheduled for May 2025. The foundations for the side access gates adjacent to the car park have been completed and the gates should be installed by end of March 2025.

The penstock valve now has an automated open / close mechanism. There was further discussion as to whether the valve was in an open or closed position at the time of the visit. The Operator has since confirmed "*the Penstock valve is now fully automated and commissioned. For clarity, it is normally open but is linked to the SCADA, so if the ERV opens the valve will close. It will reopen once the ERV is closed. For emergencies that do not open the ERV i.e. a fire, it can be closed by the touch of a button.*"

Action 1: Any Procedures relating to the penstock should be reviewed and updated to reflect the current operation. These will be reviewed at a future inspection.

Action 2: The interceptor inspection paperwork, including when it was last cleaned, should be submitted to NRW by 05/03/2025.

The yard was tidy and the bins organised.

A random selection of bins were checked to ensure these were compliant with storage times. Pallet WP00150 had been incorrectly scanned as purple rigid, cytotoxic and cytostatic waste rather than non haz pharmaceutical. Changes to the booking in system have been implemented to avoid this happening again. No other issues were identified.

There were no bins stored in the Quarantine Area at the time of the visit. NRW subsequently asked for paperwork relating to the quarantine log. This was supplied on the 29th January 2025. Gypsum waste and mattresses had been received and taken to Swindon for disposal.
