4. Details of our assessment

A routine final effluent sample collected by Natural Resources Wales (NRW) at Pentregat Housing Act Works on 29 January 2025 was found to contain 192mg/l Biochemical Oxygen Demand (BOD) when the permitted limit is 150mg/l. A category 3 non-compliance has

therefore been recorded above. A category 3 non-compliance represents a non-compliance which has the potential to have a minor or minimal impact or effect on the environment, people and/or property.

A final effluent sample previously collected by NRW at Pentregat Housing Act Works on the 15 October 2024 also failed for BOD. This was recorded in Compliance Assessment Report (CAR) CAR_NRW0045637. In response to this failure, the permit holders Ceredigion County Council (CCC) undertook a site inspection but identified no obvious cause for the BOD failure. CCC suggested that a re-seeding programme may be beneficial in restoring the site to compliance. In response to this latest failure therefore, NRW ask CCC to complete a re-seeding programme and confirm whether additional actions are required to prevent further failures by no later than the **01 April 2025**.

In this document 'Natural Resources Wales' means the Natural Resources Body for Wales established by Article 3 of the Natural Resources Body for Wales (Establishment) order 2012.
