### 4. Details of our assessment

Environment Officer Robert Andrews, visited Parkwood Dolygaer centre (Permit Number - AB3199FF) to conduct a routine site visit. The weather was very stormy and rained heavily at the time of inspection.

Officer Andrews was met on site by maintenance manager Mr Ian Le Breton. Mr Le Breton explained how the treatment process and permit operate. He informed me that the treatment plant was now operating a reed bed system instead of the phosphate removal dosing unit. This was agreed by NRW and Environment Officer Sarah Jones. Mr Le Breton then escorted me around the treatment plant. I inspected the primary, aeration

units, settlement, UV dosing, reed bed and outfall. All were operating as expected. At my request, Mr Le Breton emailed me the records of the most recent sample results and maintenance checks/records.

Only one observations was recorded as an action point. Please complete a variation on the existing permit to incorporate the reed bed treatment and removal of the ferric dosing point within schedule 1-Operations. Also add the location of the reed bed to schedule 7-Site plan

Thank you for taking the time to show us around the site and the introduction. In general, the site appeared well managed and maintained.
