## 4. Details of our assessment

This Compliance Assessment Report (CAR) is an assessment of the 2024 annual monitoring returns submitted by the operator (Viscose Closures Limited) for the environmental permit EPR/VP365SY - Cellulose Extrusion Plant Facility.

### Compliance Assessment - 2024 Annual Returns

The operator is required to submit an annual report on the performance of the activities over the previous year by 31 January. The operator submitted their annual report on 8th January 2025; within the specified reporting window as per condition 4.2.2.

The annual submission consisted of the following documents:

- Form Air1 / 06/01/14
- Form Water Usage1 / 06/01/14
- Form Energy1 / 06/01/14
- Form Performance1 / 06/01/14

The annual submission contained required information in accordance with permit condition 4.2.2.

Total Mercury in water was reported to be 0.000621kg/year. This is below the annual limit set in Table S3.4 and therefore in compliance.

The annual report included the annual monitoring results in line with condition 4.2.3. Information was submitted with 28 days of the end of the reporting period.

Monitoring data submitted including detailed measurement taken to the following permit requirements:

- Schedule 3, Table S3.1 – Point Source Emissions to Air

#### A1 – Hydrogen sulphide scrubber vent

Spot extractive sampling undertaken on the 11th July 2024, indicate that the Hydrogen Sulphide (2 mg/m<sup>3</sup>), Carbon Disulphide (105 mg/m<sup>3</sup>) and Ammonia (190 mg/m<sup>3</sup>) emission limits were not exceeded.

#### A2 – Extraction from tanks 7- 14 RTTM

Spot extractive sampling undertaken on the 5th June 2024, indicate that the Hydrogen Sulphide (1 mg/m<sup>3</sup>), Carbon Disulphide (17 mg/m<sup>3</sup>) and Ammonia (10 mg/m<sup>3</sup>) emission limits were not exceeded.

Note: This CAR report and assessment was undertaken on the 20.02.2025. However, to ensure that any non-compliance scores are attributed to the correct financial year (for billing) the date on the CARS system has been altered to 31.12.2024
