4. Details of our assessment

I (Environment Officer Gavin Dodd) arrived at Redrow, De Clare Gardens on Tuesday February 18th 2025 at 12:00 to conduct an inspection regarding a discharge of trade effluent (site drainage) to unnamed tributaries of the Nant yr Aber (Permit Number EPR/CB3596FE). Site manager Osian Phillips was also in attendance.

The site had four discharge points to the tributaries, though only two were discharging during the inspection. The discharge from both was clear, and the tributaries were running clear on both sides of the site and had no sign of discolouration or contaminants being present.
