4. Details of our assessment

This compliance form is the result of a routine inspection for the permit DP3922XG.
Attended site on 18/02/2024 and met with onsite staff. Weather was clear at time of visit.

Went into site building to check maintenance / tanker records of system which looked to be in order. The site recently had its yearly emptying on the 17th of February as well as servicing on the 13th of February.

Went outside to inspect the treatment system which looked to be in good condition. The system is large for the usage it gets due to the frequency in which the school uses the facility (used significantly less during winter months and only a few times a week through remainder of the year).



Additionally, the permit for this site indicated that the system discharges to the Rhymney River, with a sample point on the supposed outlet. However, upon site inspection, this is not the case, and the system discharges to ground via a drainage field with no sample point. This should be changed via a permit variation with NRW.

Besides the discrepancies in permit / discharge point, no further concerns and left site.
