Introduction

This Compliance Assessment Report (CAR) is an assessment of the annual submission provided by Infinis Energy Ltd (the Operator), which covers the 2024 calendar year period.

Scope

The following monitoring returns and reports have been assessed within this Compliance Assessment Report (CAR):

 - Accident Management Plan Review.

2024 – Annual Submission Review

The reporting form (*Annual Permit Report*) was submitted by the Operator on the 21st of January 2025, which was within the specified timeframe (by the 31st of January 2025) in accordance with permit condition 4.1.3.

The report detailed all informative requirements (Schedule 4: Tables S4.1 and S4.2) set out by NRW within permit condition 4.1.3. Furthermore, the Operator demonstrated the maintaining of tables relating to raw materials and waste recovery/disposal in accordance with permit conditions 2.4.1.1 and 2.6.2 respectively.

Following assessment of the annual report, the subsequent observations were noted:

- Engine downsized in 2024 in response to available landfill gas volume and quality generated by Nantycaws Phase 1 and Phase 2 Landfill Complexes.
- Performance Indicators:
 - 2268MWh Total Production.
 - 2077MWh Exported
 - Estimated 4989.6kg NO₂ produced in 2024.

- Estimated 15,422.4kg CO produced in 2024.
- Volume of Landfill Gas treated 1,315,663m³
- Engine downtime: 15.7%

Please note: This CAR report and assessment was undertaken on 21st of February 2025. However to ensure that the non-compliance score is attributed to the correct financial year (for billing) the date on CARS system has been altered to 31st of December 2024.
