Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

At this time, we do not intend to take any further action.

4. Details of our assessment

A routine site inspection was undertaken on Thursday 13th February 2025. The previous inspection of the site was completed on 25th October 2023, during which no non-compliances with the Environmental Permit were recorded.

On Thursday 13th February 2025, an inspection of waste storage and treatment areas was undertaken and the following observations were made:

Waste Acceptance & Storage

At the time of the inspection, all waste on site appeared to conform with the list of acceptable wastes in the Environmental Permit.

Waste was clearly segregated and waste storage activities were assessed as compliant. The majority of waste was stored and treated inside the building. Some specified waste was stored outside in the yard in line with the requirements of the permit. These wastes were namely mixtures of concrete, bricks, tiles and ceramics (EWC 17 01 07) and soil and stones (EWC 17 05 04).

Non-specified wastes were stored and treated inside the building.

While on site it was suggested that a trommel may be brought on to site. Prior to this plant being brought on to site, you must undertake relevant risk assessments and amend your Environmental Management System (EMS).

Site Boundary & Amenity (Emissions)

An inspection of the site boundary was undertaken. The yard is fenced but you may also wish to consider installing netting to prevent dusts/litter escaping the site given the planned changes to operations.

At the time of the inspection, the boundary was free from litter and dust was not escaping site and/or impacting adjacent properties.

Regular checks of the site boundary should be undertaken as part of your management of operations.

These aspects of operations were assessed as compliant and activities were not having an impact on neighbouring businesses/properties.

Actions

A small number of building sacks containing plasterboard were being stored outside in the yard. It was noted this was a temporary measure to allow access to the main building.

These items were moved during the inspection and placed inside the building. You must ensure this waste is stored inside the building at all times.

Summary & Next Inspection

Waste storage and treatment areas were inspected and activities were assessed as being compliant with the Environmental Permit.

You should consider the potential impacts of operations if waste treatment practices change (such as the introduction of new plant & equipment).

It is possible that during the next inspection, officers will assess compliance with the site 'Fire Prevention & Mitigation Plan', and request records for certain waste streams that have been removed from site.
