### 4. Details of our assessment

NARBERTH WEST STW was visited on 27 February 2025

The site is attended daily with de sludge tankers scheduled weekly.

According to the permit the site has an overflow setting is 28 litres per second. 16.1 litres per second was observed during the visit. The operator indicated that the flow passed forward is consistently achieved.

Final effluent sample point was observed during the visit and appeared clear.

No issues on site, no evidence of non-compliance.
