Site inspection undertaken by Michael Edwards of Natural Resources Wales, met on site by Peter Harts TCM and Sarah Edwards of Pembrokeshire County Council.

### **B1 Engineering for prevention and control of emissions.**

Under the current conditions of your permit (**conditions 2.1.1 and 2.3.1 (a) referring to Schedule 1, table S1.1**), waste is required to be treated and stored on an impermeable surface with **sealed drainage to foul sewer**.

At present the current system on site enables both internal and external surfaces to drain into an open channel along the wall of Unit 41 before connecting to the adjacent foul sewer.

### **B4 Containment of stored materials.**

Under **conditions 2.1.1 and 2.3.1 (a)** you are required to store waste on impermeable surfaces which drain into foul sewer. During the inspection, waste was stored in the manner described in the sites environmental management system with no issues identified.

### **C1 Staff competency and training.**

Under **condition 1.1.1 (b)** the operator is required to use sufficient competent persons and resources, and under **condition 1.1.2** records demonstrating compliance with **condition 1.1.1** must be maintained. **Condition 1.1.4** sets the requirement for the operator to use an approved competency scheme. Evidence was provided on site for Peter Harts the TCM for the site, completing his WAMITAB continuing competency.

### **C2 Management systems and operating procedures**

During the inspection the site operated in line with the submitted Environmental Management System (EMS), '**Operating Techniques Document V0.4**' as required by **condition 1.1.1**.

The EMS, Fire Prevention and Mitigation Plan (FPMP) and Permit were all available on request in the site office as required by **condition 1.1.3 and condition 4.1.2**.

Maintenance records were available during the inspection, with daily and weekly site inspections undertaken by the operator.

### **D1 Site Security**

No issues were identified with site security during the inspection.

### **F1 Odour**

No odours were detectable outside of the operating areas this is in line with **condition 3.2.1** of the permit.
