4. Details of our assessment

On the 21st February 2025 I attended the site on an un-announced inspection. The weather was cold and wet with some heavy rain showers.

On site I was met by the site manager from Watson Fuels who undertook my site safety briefing before accessing the site proper. We inspected the interceptor chamber and discussed it's siting and history. I was advised it was regularly inspected and emptied by contractors, with receipts available on request. There was no sign of any damage or impact from the groundwater discharge on nearby streams. The bunding around the storage tanks appeared to be sound with relevant signage in place.

We also discussed ownership of the site and permit, and this CAR form is being issued to the contacts on site as well as the registered permit holder, to ensure all details can be updated to accurately reflect current operations on site.
