**4. Details of our assessment****Abril Industrial Waxes Annual Reporting CAR**

The purpose of this compliance assessment report is to review the quarterly monitoring returns for Q4 (October to December) 2024, the annual returns as required by permit condition 4.1.2 and 4.1.5.

**Quarterly reporting for emissions to Air and Sewer**

The Q4 reports were received on 23<sup>rd</sup> January 2025 and showed no emissions breaches to air during this period. The emissions to sewer report showed all parameters to be within the consent limits.

**Annual returns – waste disposal and recovery**

Hazardous waste produced by site showed a decrease when compared to 2023. Non-hazardous waste production Increased since 2023. Abril reported that the increase non-hazardous waste in 2024 was due to the disposal of redundant material, products, and equipment.

**Annual returns – Water usage**

A total of 172m<sup>3</sup> of water was used by the site in 2024, an increase when compared to 2023 figures. Water used per unit output has remained consistent with previous years.

**Annual returns – Energy Usage**

Energy usage has slightly increased in 2024 when compared to annual figures from 2023. Abril also note that electricity is now sourced from 100% renewables.

**EMS Objectives and Targets**

As of 25th February 2025, NRW have not received a summary of Abril's objectives and targets for 2024 as required by permit condition 4.1.5.
