4. Details of our assessment

A routine site inspection was undertaken on Friday 14th February 2025. Present at the time of the inspection were: David Morgan, Angharad Clark (Natural Resources Wales) and Gary Samuel (Recycling Equipment UK Ltd).

The previous inspection of the site was on 23rd October 2023, during which no non-compliances of the Environmental Permit were recorded.

On Friday 14th February 2025, an inspection of operations was undertaken and the following observations were recorded:

Waste Storage

It is noted that skip waste (largely from construction & demolition sources) is tipped in the main shed. Treatment (sorting) takes place inside the building and some waste (namely scrap metal and oversized hard plastics) is stored outside in concrete bays.

The Environmental Permit requires mixed wastes, mixed municipal wastes (European Waste Code [ewc] 15 01 06 and 20 03 01 respectively) and asbestos wastes to be stored inside the building. Paper and cardboard waste must be stored in the building or outside in a curtain sided trailer.

All other waste, and inert waste, can be stored outside in concrete bays.

At the time of the inspection, waste storage practices were assessed as being compliant with the Environmental Permit.

In one concrete bay, a small volume of plasterboard was stored under cover. This waste should be quarantined and stored inside a building/container to prevent escape of dust and ingress of rainwater. At the time of the inspection, this did not appear to be having a detrimental impact on the environment, but you must consider how plasterboard is stored in the future.

Records Management

Copies of the Environmental Permit, Environment Management System and Fire Prevention & Mitigation Plan are available on site, but in digital format. You should consider having print out copies of these documents so they are readily available to all staff in the event of an incident.

It is likely, that in the next inspection, Natural Resources Wales will assess compliance with the Fire Prevention & Mitigation Plan. We may also wish to assess other records such as Waste Returns and to discuss how wood waste movements are recorded as it was noted some wood waste is treated under an exemption in another area of the property.

No non-compliances were recorded during the inspection.
