**4. Details of our assessment**

Angharad Clark attended site for a routine inspection on 7th February 2025. She met with the TCM who showed her around. The weather was cold and dry following a period of rain.

**Site Infrastructure**

The drains on the lower concrete pad were partially blocked causing pooling of water. The pooled water was contained within the site. I took a photo. The TCM agreed that he would unblock the drains within two months.

**ACTION: Unblock drains on lower concrete pad before 7th April 2025.**

**General Management**

The permit was readily available on request. The site has expanded the non-permitted area to the front of the site to accommodate storage of empty skips. The site was generally well maintained and the concrete pad appeared intact.

**Permitted Activity**

There was a large volume of fines on the site, although they were well segregated from other waste streams. The TCM explained that the ability to reduce the size of the fines particles was hindered by the recent rainfall. This would be rectified over the coming months and the fines would then be disposed of to Trecatti Landfill as cover. There was also a large amount of waste wood on site, again, well segregated. The TCM explained that this was as a result of the increased volume of fines on the site preventing the ingress of the wood lorry. This would too be rectified in the coming months.
