4. Details of our assessment

This Compliance Assessment Report (CAR) follows the review of Q3 monitoring returns (July-September 2024) for emission points W1, W2 and S1. This data was received by NRW within the timescales required by the permit.

All parameters were within the permitted Emission Limit Values (ELVs) and therefore compliant.

Chemical Oxygen Demand (COD)

On 16/08/24, emission point W1 recorded a maximum Chemical Oxygen Demand (COD) value of 44mg/l vs a permitted ELV of 70mg/l.

On 17/08/24, emission point W2 recorded a maximum COD value of 42mg/l vs a permitted ELV of 70 mg/l.

Biological Oxygen Demand (BOD)

Both monitoring points recorded maximum values which were within the ELVs for BOD (30mg/l).

On 04/09/24, emission point W1 recorded a maximum BOD value of 3.64 mg/l.

On 04/09/24, emission point W2 recorded a maximum BOD value of 4.42 mg/l.

Suspended Solids (SS)

Both monitoring points recorded maximum values which were within the ELVs for SS (50mg/l).

On 19/09/24, emission point W1 recorded a maximum SS value of 34 mg/l.

On 30/09/24, emission point W2 recorded a maximum SS value of 28 mg/l.

Emissions to sewer

Emission point S1 recorded the following maximum values:

COD- 163mg/l - 05/08/24

TSS- 77 mg/l - 05/08/24

Flow (m3/day)- 989 m3/day- 21/08/24.

There are no permitted ELVs associated with emission point S1.
