4. Details of our assessment

This Compliance Assessment Report (CAR) follows the review of the 2024 annual monitoring and returns data. This data was submitted to Natural Resources Wales (NRW) on 24/02/25, which is after the reporting deadline specified in the permit (31/01/25). NRW considers this a breach of permit condition 4.2.2 and a non-compliance score has been applied (IR4B-Reporting-C4).

Action 1- Ensure annual monitoring returns are submitted by the date specified in the permit

Annual emissions testing (total particulate matter) was carried out on the following emission points A12,A15 and A16 on 28/11/24 and A14 on 22/10/25 by an MCERTS accredited third-party test house.

Emission points A12, A14 , A15 and A16 recorded values of 4.1 mg/m³, 4mg/m³, 1.3 mg/m³ and 10.5 mg/m³ respectively. This is below the permitted Emission Limit Value (ELV) of 20 mg/m³.

With reference to form E1, energy use in 2024 was 20750.18 MWh which was lower than during 2023 (22021.18). 3765.6 tonnes of CO₂ were produced in 2024 compared to 3998.55 in 2023.

With reference to form WU1, water use in 2024 (23942 m³) was less than 2023 (26406 m³).

With reference to form R1, waste produced in 2024 (205.63 tonnes) was less than waste produced in 2023 (217.756 tonnes).

With reference to form PI1, animal feed production in 2024 (348885.32 tonnes) was lower than 2023 (357357.78 tonnes).
