Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

You are non-compliant with your permit.

At this time, we are issuing you with a warning for the non-compliance recorded above. Warnings may influence future enforcement response for continued or further non-compliance.

This statement does not stop us from taking additional enforcement action if further relevant information comes to light or offences continue.

4. Details of our assessment

This Compliance Assessment Report (CAR) follows the review of Q4 monitoring returns (October-December 2024) for emission points W1, W2 and S1. This data was received by NRW on 24/01/25, which is within the timescales required by the permit.

Point source emissions to water (other than sewer)

Chemical Oxygen Demand (COD)

Both monitoring points (W1 & W2) recorded values within the permitted Emission Limit Value (ELV) (70mg/l) for COD during Q4.

W1 recorded values between 0-49mg/l.

W2 recorded values between 0-45mg/l.

Biological Oxygen Demand (BOD)

Both monitoring points (W1 & W2) recorded values within the permitted ELV (30mg/l) for BOD during Q4.

W1 recorded values between 1.04-9.29 mg/l.

W2 recorded values between 0.7-6.06 mg/l.

On 03/01/25, the operator notified NRW that the external lab had not completed sampling for BOD on any of the samples sent during December. The operator is awaiting a full response from the lab as to why the required sampling was not completed.

NRW considers this a breach of permit condition 3.5.1 and a non-compliance score has been applied (IR3E-Monitoing-C3).

Action 1: Provide NRW with a written update on your investigation into why BOD sampling wasn't completed by the external lab and the measures that have been put in place to ensure this sampling is completed going forward.

Suspended solids (SS)

W1 recorded values between 0-52 mg/l. This is above the permitted ELV of 50mg/l. However when the uncertainty value for sampling is applied (+/- 14.38%), this gives a value of 44.53 mg/l which is within the permitted ELV.

W2 recorded values between 0-38mg/l which is within the permitted ELV.

Emissions to sewer

Emission point S1 recorded the following maximum values:

COD- 100mg/l

SS- 183 mg/l

Flow (m3/day)- 825 m3/day

There are no permitted ELVs associated with emission point S1.
