4. Details of our assessment

Angharad Clark attended the site on 7th February 2025. She met with the Standards Engineer who showed her around. This was a routine inspection, the weather was cold and dry following a period of rain.

General Management

The site has increased operations since my last visit. More waste is being processed whilst research and development has been reduced. The Standards Engineer explained the daily checks that are carried out. Over-boots are provided to prevent the transport of dust from one part of the site to another.

Recovery of waste produced by the activities

The site removes and granulates cathode material from battery parts using a unique treatment method. One of the waste streams generated from this treatment is an aluminium dense material. It is stored on an impermeable pad in sacks for removal from site for onward processing. Please see photo.

Permitted Activities

All waste is stored within the permitted area and no emissions, including noise and vibration have been reported or detected. Separated waste streams are well segregated pending onward treatment. The unique treatment is carried out indoors.

The Site

The impermeable pad is maintained in excellent condition. The site is secure with no amenity breaches.

General Observation

There were no issues/breaches observed during the inspection.
