4. Details of our assessment

Compliance inspection at Aberthaw East STW AF4027601 undertaken by Environment Officers Harry Warburton and Hannah Jenkins, accompanied by DCWW. The weather at the time was dry.

The site has had historical odour complaints, currently there are covers over the inlet and the final humus tank. There is a Nutriox setup available to dose the effluent to address the odour as a trial, this is currently not being used but will be in the near future.

The site consists of an unscreened inlet to a septic tank, which gets desludged frequently as per the permit condition. Following the septic tank is a percolating filter bed. The arms of the bed were not rotating as they appeared to be at a slant, so the effluent was favouring one arm. Due to the filter bed arms having little to no rotation the effluent was not being distributed evenly which could effect the level of effluent treatment.

Following the filter bed is a humus tank and the final effluent sample point. There was low flow through the channel. There was also a build up of white growth on the FE channel.



The outfall is to the River Thaw which is quite a distance from the site. This was not inspected, however has been by DCWW.

Action

- Return function to the rotating arms on the filter bed to allow for even effluent distribution.
