4. Details of our assessment

A site inspection was undertaken on Thursday 20th February 2025. Present during the inspection were: David Morgan, Edward Davies (Natural Resources Wales) and Stuart Hanford (Derwen Recycling Ltd).

A site inspection was undertaken and the following observations were made:

Waste Acceptance, Storage and Treatment

At the time of the inspection, all waste was being accepted, stored and treated in the main building. An overview of recycling operations was provided and wastes were clearly segregated. Processes for treating various waste streams were discussed. Each stage of the process for accepting, treating waste to it leaving site as Refuse Derived Fuel (RDF) was observed.

We discussed incident management (specifically fires) and we talked through the process of how incidents are identified, managed (i.e. plant and machinery available, out of hours monitoring and quarantine areas etc.) and relevant incident recovery measures.

To the rear of the site, in the open yard, all waste was segregated and stored in bays undercover. Generally, the site appeared to be well managed and site infrastructure is maintained to a high standard. There was no noticeable damage to site surfaces and drainage systems in this area were working efficiently.

We discussed some changes to operations that had taken place in terms of layout of waste operations and how this should be reflected in the site's Environment Management System (EMS).

At the time of the inspection, all aspects of waste acceptance, storage and treatment were assessed as being compliant with the Environmental Permit.

Emissions & Amenity

At the time of the inspection, the site was operating at regular levels. Operations were not perceived to be having a detrimental impact on the local amenity. There was no noticeable noise emanating from site prior to our arrival.

Also, there were no signs that waste/litter was escaping site and there was no mud, debris leaving site or on access roads.

Environment Management System

It was agreed that an up to date copy of the Environment Management System would be provided to ensure Natural Resources Wales has the latest copy which reflects current operations.

Generally, the site is well maintained and no non-compliances with the Environmental Permit were recorded. It is likely that the next site inspection will focus on records management (waste returns information, training records etc.)
