4. Details of our assessment

On 21st February 2025 I attended the site on an un-announced inspection. The weather was wet with heavy rain showers.
 On arrival, I checked in at reception and was shown the relevant areas of the site which appeared to be clean and well maintained. I was advised the interceptor is managed on contract with a 3rd party which regularly inspects and empties the interceptor, with receipts

and records available on request. No sign of oil was visible across the site and all drainage appeared to be appropriate.

In discussion with the site manager, it became clear that Certas were unsure who held the permit (Certas or GB Oils) and this needs clarifying, however the site manager was unsure who this sits with. This may need amending as per permit condition 4.3.4.
