4. Details of our assessment

Unannounced site inspection undertaken by Rachel Mallinson of Natural Resource Wales.

Waste Storage

Site tour conducted during the inspection, waste stored in appropriate containers and designated areas in line with condition 1.1.1a of the environmental permit. Wastes were well segregated in labelled skips. No non-permitted wastes identified during the inspection.

Minimum staffing and supervision

Incident Management Plans were not available when requested on site. A non-compliance of the Condition 1.4.1 of the permit has been recorded. You must have copies of the incident management plans on site and all staff must have access to these plans

Staff competency

Evidence demonstrating the continuing competency of Karen Davies has been provided as required under condition 1.4.3 and is valid until 24/07/2025.

Site Engineering for pollution prevention and control

Pooling on the impermeable pavement was identified during the inspection. A non-compliance of the Condition 2.1.2 of the permit has been recorded. You must maintain drainage systems to stop blockages forming in order to prevent pooling.

During our inspection the site boundary appears to be secure. However, new fencing is due to be installed around site perimeter. Current Palisade fencing is being upgraded due to recent security issues.
