4. Details of our assessment

Resources Management (UK) Limited (RML) operates Withyhedge Landfill under the provisions of an EPR Permit (MP3330WP). The Site is a non-hazardous landfill and was constructed in two phases. Phase 1 accepted waste from 1985 until its closure in 2006. Phase 2 is where the current active tipping area is found at the Site.

Introduction

A site visit was undertaken on the 21st February 2025 to assess general compliance with permit conditions.

NRW Officers were accompanied at times throughout the site visit by the Technically Competent Manager (TCM) and Site Foreman.

Site Observations

Waste Transfer Station (WTS)

On arrival, NRW officers completed an independent visual inspection of the waste already deposited within the WTS's bays – for eventual disposal at the landfill.

No evidence of any banned or prohibited wastes were observed in any of the wastes we inspected.

The wastes we observed within the WTS appeared to be shredded general waste. The Operator confirmed the wastes were non-hazardous shredded general waste (19 12 12) which is listed on the EPR permit for the landfill and WTS (QP3098FL).

A Gazomat methane detector was used to check the waste found deposited within the WTS's bays; no elevated readings were noted.

Operational Area (Cell 9)

Waste disposal activities within Sub Cell A have reached a height of approximately 6m. In line with the waste phasing plan (CAR_NRW0045933), waste disposal activities have now commenced in Sub Cell B.

The intermediate cover layer has been extended to cover the majority of Sub Cell A. The material used appears to be formed of cohesive, impermeable soils which appear suitable as intermediate cover.

The gas main associated with Cell 8 has been extended along the Cell 8/Cell 9 intercell bund to allow for the horizontal gas wells within Cell 9 to be connected to the gas abstraction system. The waste within Cell 9 (Sub Cell A) is not currently generating sufficient quantities of landfill gas to be collected, however the infrastructure is in place to provide abstraction when required.

The operator confirmed that the site's gas technician is regularly monitoring the gas wells. The operator is reminded that when the gas wells are turned on, gas suction must only be applied very carefully and gradually.

No evidence of any banned or prohibited wastes were observed during the inspection¹.

A landfill gas check of methane emissions was undertaken by NRW officers at various points across Cell 9 (Sub Cell A & Sub Cell B) using a Gazomat methane detector. The results of the survey indicate minimal surface emissions of methane.

NRW Officers confirmed that the leachate well associated with Sub Cell B had been connected to the leachate extraction system.

Odour Assessment

No malodorous emissions were detected by the NRW officers at any location during the duration of the site inspection; either in the WTS or at the landfill.

Surface Water Management

The current surface water emission point for the Site – D1 – was inspected; no visual evidence of pollution was noted.
