4. Details of our assessment

A site visit was conducted with two NRW officers and three WEPA employees. It was dry at the time of our visit.

During the visit, the abstraction points were inspected and appeared to be well-maintained.

We were given a helpful presentation on the abstraction process.

Grid references for Points A and B were confirmed to be accurate, corresponding to the locations given on the permit.

There are two separate meters installed in accordance with the permit. Data is electronically recorded weekly and sent to PI data collection technology system.

pH and temperature readings are taken at Point A before water is pumped to the site. The meter at Point A is scheduled for calibration in February next year.

The Nant Gwyn runs through the site, a meter is fitted at this point (Point B). There is the option to bypass straight into the Llynfi river.

The abstraction data for the year 2022/2023 was reviewed and confirmed to be below the maximum allowable abstraction quantity. Calibration records were received via email and verified to be within the required timescale for calibration checks according to the manufacturers recommendation.
