4. Details of our assessment

I, Industry and Waste Regulation Officer Magda Leonowicz, and Apprentice Enforcement Officer Daniel Hopkin, attended Scott Walton Contracting permitted facility at New Barn, Barry, CF62 4AJ (EPR/CB3190ZE) on Thursday 6th February 2025.

The standard rules permit '*SR2009 No6 - Inert and excavation waste transfer station with treatment*' was issued on 26th of May 2021. The operations at the site were very limited and were carried out only for a short period of time. I am not aware of any pollution incidents that could have occurred at the site during the life of the permit.

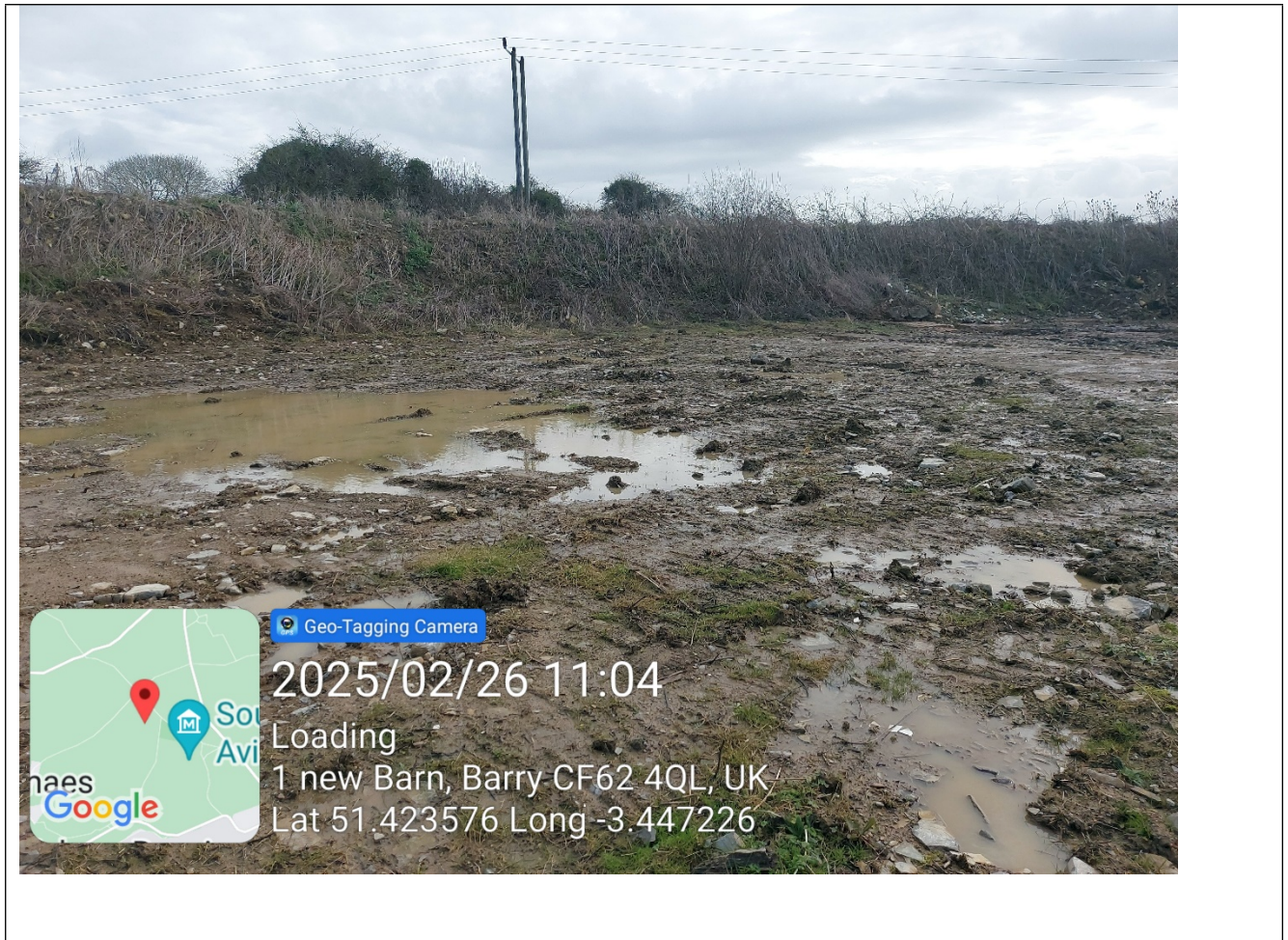
The purpose of the visit was to reassess the condition of the site in relation to the full surrender of the permit. The visit was unannounced. The weather was dry, cold, and sunny with a good visibility.

During the visit, I conducted a visual inspection of the site. The site had recently been taken over by the landowner, who burned wood as part of his farm work. Some unburnt logs were present at the site, making it unsuitable for surrender. Following the visit, I requested the permit holder to clear the site and e-mail the photographs as evidence.

The permit holder provided the photographs on the 28th of February 2025. Having reviewed them, I can confirm that the site has been cleared and is now in a suitable state for the permit surrender.
