## 4. Details of our assessment

This report details the site visit made on the 26th February 2025 to ReCover Blaenavon Ltd, permit reference number EPR/DB3090FA. Natural Resources Wales (NRW) Officer Greg GARDNER and Carla CURTIS attended the ReCover Blaenavon Ltd site at the Kays & Kears Industrial Estate, Blaenavon, Pontypool, NP4 9AZ for an unannounced site inspection at 10:00am where we met with the Site Manager and Environmental Consultant. The weather was wet and reasonably cold.

### **GENERAL OBSERVATIONS**

ReCover, Blaenavon Ltd are seeking a permit surrender for the whole site, under permit EPR-DB3090FA. The purpose of the visit was to complete a final site inspection to facilitate the determination of the surrender application.

At the time of the inspection, all waste(s) and associated plant and machinery had been removed. All outstanding actions from previous CAR forms have been completed and signed off by the regulating officer.

Based on the visual inspection of this site, NRW Officers feel that the risk to the environment is sufficiently low and would recommend that no intrusive site is required.

To confirm, based upon the type of permit held by ReCover Blaenavon Ltd – (Permit Number - EPR-DB3090FA) and operations previously undertaken on site, it is my recommendation that this permit would be eligible for a low risk surrender.
