3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

At this time, we are issuing you with a warning for the non-compliance recorded above. Warnings may influence future enforcement response for continued or further non-compliance.

4. Details of our assessment

A data request was submitted, covering 1st January 2024 until 31st December 2024, however, the EDM (Event Duration Monitor) data was incorrect for period 19/06/23 - 09/12/24 due to static signal (flatlining) - this was excluded from the reporting.

Flow data was provided, however, this data from 09/12/24 to the 11/12/24 reads 0 l/s but there is a large (2 block counts) spill recorded by the EDM recorder during this time. This was discussed with DCWW and it was shown that there was a fault with the flow meter at the time. Other telemetry was available and this spill was due to high inlet flows and is therefore compliant.

This asset was not included in the >90% EDM reporting returns for 2023.

Action: Please ensure that this asset is included in the 2024 annual return as the reading was flatlined and therefore does not meet minimum 90% recording threshold.

Action: Improve communications and increase EDM recording to above 90% for 2025.
