POLLUTION CONTROL INSPECTION AND SITE MEETING

4th March 2025 @ 10:00hrs

Energy Efficiency/Sustainable Management/Bunding and Anti-Pollution Works

A meeting and site inspection was convened at Leprino Foods site in Llangefni to discuss the latest developments in pollution control and sustainable management under conditions 3 and 1 of the environmental permit respectively.

Issues discussed included:

- **New boiler installation**

The installation of new boilers was discussed as the existing boiler is now approaching 50 years old. An area outside the current footprint has been identified which would make the transition easier. This will be a £2 million development and will improve energy efficiency significantly.

- **Energy Efficiency**

Site wide energy efficiency measures were discussed which include the replacement of boilers but also many other initiatives which will reduce water usage and waste. These areas are progressing exceptionally well.

- **Waste Consolidation and Reduction in Land Spreading**

Options to reduce the water in the waste whey stream include a centrifugal separator. Also site is looking into alternative disposal mechanisms to reduce reliance on land spreading.

- **Site anti -pollution works**

Previous bunding works are now complete and operating well.

ACTION:

There is still an issue with the ammonia pipes close to the SW sampling point. A review should be conducted as discussed on site and options presented to NRW within 6 weeks of

the date of this report.

- **SMNR/Land Purchase, Offsetting and Wetland Development and Treatment Options.**
Land purchase has been agreed and more than 20 acres of land surrounding the facility will be in ownership going forward. This leaves multiple options for offsetting future construction work and developing an ecosystem services landscape which may include a UK first wetland treatment scheme.
- **Amenity, ESG, Local Impact and Outreach.**
This was discussed in the context of local outreach and there are multiple options to create a shared environment with the river corridor for the community to enjoy. These will be the subject of future discussion.
