### 4. Details of our assessment

**Site report**

On 13/02/2025 Environment Officers from NRW met with the Site Manager for Penderyn Quarry for a compliance inspection of activities permitted by the site discharge permits (AN0238501, AN0272901, AG0001901) and abstraction licence 21/57/23/51. The weather was dry and cloudy. This report is for EPR permit number AN0238501.

This permit is for the discharge of site drainage via 2 settlement lagoons (shown in Figure 1 below) and the discharge of storm site drainage.

Some discolouration could be seen from the water entering the lagoons, however the water being discharged from the lagoons was clear (see Figure 2).

The onsite turbidity meter stated that suspended solids (milligram per litre) in the point A1 discharge were approximately 1.1mg/l, and 0.4mg/l at point A.

Storm discharge was dry at the time of the visit.

- Provide monitoring records and results for the discharge points permitted by AN0238501 for the past 12 months by **31/03/2025**.
