4. Details of our assessment

A routine compliance inspection of Wrexham Incinerator was undertaken on the 26th February 2025 during a routine shutdown. The Site Manager, Plant Manager, SHEQ Officer and Head of Operations were on site for the visit.

Discussions were held prior to the site inspection in relation to recent dioxin exceedances, schedule notifications, waste returns and the annual performance data. Further information is required from the Operator in relation to these issues as identified in CARs NRW0045922 and NRW0046008.

There is extensive work being undertaken during the shutdown. At the front end a new kiln ring is being installed and work is being undertaken on the rams and the guillotine door. Scales are being installed under the primary bin lift to more accurately measure the weight of waste going through the kiln. Within the kiln there is a section of brick work to be replaced. At the discharge end a new elbow, crossover and air box are to be installed. The ash box is being removed and replaced.

During the site visit a number of contractors were onsite undertaking works. It was possible to see into the kiln to view the extent of the brick replacement and view the new kiln ring. The elbow had been removed and contractors were working on removing the air box.

The bag filter socks are being replaced as part of the shutdown. The Operator stated that on inspection the bag house was damp, possibly as a result of the recently installed SNCR process. This was being looked into as part of the investigation into the recent dioxin exceedances. The Operator is also looking to change the carbon being used for abatement at the site.

The delivery of waste was being controlled via the rear entrance to avoid impacting the kiln contractors. The Operator had diverted some waste so it was delivered directly to other facilities to avoid stockpiling and creating further transfer operations at Wrexham.

It is anticipated that the site will start up towards the end of March 2025.

Action: The Operator should keep NRW updated in relation to the start up date and subsequent dates for emissions monitoring. Dioxin monitoring is required within the first week of operation after steady operational state has been achieved.
