BIRD ISSUES MONA AD – RAF VALLEY

Following a report of large numbers of birds (mostly starlings) feeding on material stored at Anglesey Energy permitted site, by Air Traffic Control at RAF Valley, the following actions were requested to be undertaken as quickly as possible to reduce the risk of bird strike to jets in the area:

- Covering feedstocks with plastic tarpaulin
- Ordering bird proof netting to cover the whole of the clamp area
- cleaning any windblown and other feedstock from around the site
- Installing a new bird scarer
- Changing feed and management protocol

In a site visit on the 3rd February, all actions had been expedited and bird numbers had reduced to the extent that RAF Valley confirmed there were no further issues.
