4. Details of our assessment

On the 24th April 2024 an unannounced site inspection was undertaken at TS Reasons Limited, Alyn Works, Denbigh, Mold, Flintshire, CH7 1BT by NRW officers Phil Harper and Kathryn Bradshaw (Senior Industry & Waste Regulation).

At the time of the inspection the site was operational.

General Site Condition.

Visually the site appeared to be clean and tidy. Site improvements, including the installation of new cooling towers were ongoing at the site.

Waste Storage

Historical waste which had previously been observed stored at the site boundary had been removed. Wastes are routinely produced by the operation in the form of process washings. A minimal quantity of IBCs containing washings were positioned at the site boundary. The operator was able to demonstrate that wastes were stored in this area for a minimal amount of time before being removed from the site.

NRW would like to remind the operator that it is best practice to ensure that IBC containers which contain liquids should not be stacked higher than a single IBC at the site boundary to reduce the risk of IBCs being tipped onto unmade ground or jetting to unmade ground from leaking IBCs.

No permit breaches relating to the storage of waste have been identified.

Site Bunds.

Rain had occurred at the site throughout the night prior to the site inspection, bunds appeared to be in a good condition and water levels had been kept to an acceptable level.

No permit breaches relating to site bunds have been identified.

Waste Consignment

The operator has recently changed which the waste carrier for some of the waste produced by the activities. Waste transfer notes have been provided to NRW for review.

No issues have been identified.
