### 4. Details of our assessment

#### **Site report**

On 13/02/2025 Environment Officers from NRW met with the Site Manager for Penderyn Quarry for a compliance inspection of activities permitted by the site discharge permits

(AN0238501, AN0272901, AG0001901) and abstraction licence 21/57/23/51. The weather was dry and cloudy. This report is for EPR permit number AG0001901.

During the site visit it was unclear whether this discharge has now been combined with the discharge for permit AN0238501, or whether there is still a separate discharge. Correspondence with the site manager on 19th February 2025 confirmed that the separate discharge is still in use and that samples of the discharge are taken quarterly during maintenance.
