On 13/02/2025 Environment Officers from NRW met with the Site Manager for Penderyn Quarry for a compliance inspection of activities permitted by the site discharge permits (AN0238501, AN0272901, AG0001901) and abstraction licence 21/57/23/51. The weather

was dry and cloudy.

This report is for abstraction licence 21/57/23/51.

No recorded abstraction at the licenced location.

Actions required

Previous CAR form issued in 2021 states that infrastructure for abstraction was never built and the recommendation was to surrender the licence if the abstraction was not required.
