4. Details of our assessment

A routine sample taken on 17 February 2025 at Station Number 6130024, returned an Ammoniacal Nitrogen result of 32.6 milligrams per litre against a permit limit of 13 mg/l.

The sample also indicated a Suspended Solids result of 65.5 mg/l against a permit limit of 30mg/l.

There was also a result for BOD: 5 Day ATU of 24.7 mg/l against a permit limit of 20 mg/l.

Our enforcement response is as indicated in this CAR form. This may change should new information come to light, following your updated response.
