NRW are still awaiting for the permit variation for the site to be completed. Information for the application is still outstanding, Mr Jones telephoned his consultant Ben Rees and Ben informed us that the outstanding information would be submitted to our permitting department later today. *

Site was fairly clear and good segregation of waste types was observed.

There were less than 10 ELVs on site and 9 of these had been depolluted. Only one ELV remained in the depolluting bay. Mr Jones explained that he was in the process of moving all of the scrap metal of site to his new exempt site on a different part of the airfield. As a result of this he was currently not accepting ELV's and had not done so for a number of weeks.

Mr Jones explained that it was his intention to clear the site within the next week or two and than complete improvement works to the impermeable pad and site drainage when clear. He will take photos and submit them to us when the work is done.
