4. Details of our assessment

Site Report

On Tuesday 18th February 2025, I visited Park House Farm, Rhiwderin, Newport NP10 8RP to undertake a Water Discharge (Sheep Dip) permit inspection on Permit Number GWSE1377. I arrived on site at 11.20am. The weather conditions were dry and sunny. My Site inspection commenced at 11.25am.

Observations

I was met by Mr John Griffiths who identified himself as the permit holder. After our

introductions I agreed to a walk around of the site with Mr Griffiths present.

I questioned Mr Griffiths with regards to the type of sheep dip that was used on site and the storage method and storage location. Mr Griffiths advised that no sheep dip was kept on site. Mr Griffiths advised the sheep dip was delivered to site on the day the sheep dip activity was due to commence and any sheep dip not used was taken away by the supplier (AS Dipping, Ludlow)

I asked Mr Griffiths to identify the location where the sheep dip activity is conducted. The location was a closed off area of a barn. I can confirm there were no watercourses near this location. Please see Fig 1 and 2 below.

I continued my discussion with Mr Griffiths regarding the sheep dip process. Mr Griffiths advised the sheep dip activity has only been carried out once in the last 10 years. The last time was February 2024. Approximately 500 to 700 sheep. The activity was carried out by

AS dipping, Ludlow and the used sheep dip was taken away by the contractor.

My site inspection commenced at 11.50am
