#### 4. Details of our assessment

Cabot Operator Monitoring Assessment (OMA) 2025 CAR.

The OMA Report is stored on the DMS and has been sent separately by email. Overall Cabot gained a good score of 83% and have shown that quality assurance for periodic monitoring is generally well managed, providing reliable monitoring data. Competency of Periodic Monitoring scored highest since the testing company is MCERTs accredited. A brief assessment of section 3, continuous monitors, was undertaken but not scored since this is only used for process control.

Some inconsistencies were found within the environmental management system and advisory actions were given within the report to improve the general management of monitoring.

**Action:** Ensure that all advisories listed within the report are completed by 31<sup>st</sup> March 2025.
