4. Details of our assessment

Following a report from a member of public that effluent was overflowing a tank at Danyrhelyg

treatment works, officers attended and found the the primary tank had not been emptied and untreated sewage was overflowing the tank, before running across the ground and entering the filter bed.

Without a working settlement tank to remove solids from the sewage the filter bed is likely to become blocked. This will cause a deterioration in final effluent quality.



Carmarthenshire County Council must ensure their treatment works are maintained and serviced regularly to prevent issues with treatment quality.
