### 4. Details of our assessment

Following a report of pollution in the watercourse downstream of the Bryndulais Sewage treatment works we met with you on 12/07/2024 to inspect the works and ensure compliance with permit BH0055602. During our inspection we were unable to access the works compound but could see

that the discharge from the outlet of the works was causing heavy growth of sewage fungus in the water. There is little flow in the watercourse upstream of the sewage treatment works and during dry weather the effluent will be undiluted in the watercourse.

The treatment works appeared to consist of a settlement tank and bio-disc filter.

We discussed access issues at the site as tankers would need to cross a field to access the works which may be difficult following wet weather.

Although it was not clear without inspecting the works closer, the works most likely required maintenance as you were unable to tell me when the site had last been serviced.

Carmarthenshire County Council must ensure their treatment works are maintained and serviced regularly to prevent issues with treatment quality.
