Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

4. Details of our assessment

A pre-arranged familiarisation visit was undertaken by the NRW Regulating Officer for the Facility on the 10 March 2025.

The NRW officer was accompanied by the EHS Co-ordinator during the inspection of the main operational area and the waste storage provision of the Facility.

The concrete bund adjacent to the "Job Shop" and the "decontamination" bund were observed to be full of water, significantly limiting their containment potential. The waste water bulk tank was located within what appeared to be an unsealed bund. The Operator was unable to confirm if the tank was double skinned or comprised integrated a 110% containment.

Notwithstanding the above the Facility appeared to be tidy and well managed, with little or no evidence of poor house keeping, leaks or spills of materials or wastes.

Based on the observations of the familiarisation visit and subsequent meeting to discuss activities at the Facility, a number of Actions were agreed.

Actions.

1. Review procedures associated with the inspection and maintenance of bunds and update to include provision for removal of accumulated water, maintaining the required containment potential of the bund. Provide evidence to NRW by 10 June 2025.

2. Confirm whether or not the construction of the waste water tank provides 110% secondary. Provide confirmation to NRW by 10 June 2025.

3. Confirm the number of space heaters, the year(s) of installation, fuel source(s) and the capacity (MW) of each heater. Provide the information to NRW by 10 June 2025.
