Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

### 4. Details of our assessment

On the 13th February 2025 you accompanied us on an inspection of Southgate Sewage Treatment Works (STW). It was dry weather during the inspection and it had been dry weather on the days before.

Southgate STW has a permit to discharge treated Final Effluent only. There is no permit in place to discharge storm sewage.

The incoming sewage flows into the works and are screened by a 6X6mm mechanical screen which

is alarmed. The screen appeared clear during the inspection. We observed quite a large amount of food waste within the inlet flows. We discussed this with you and you said it didn't appear abnormal. There was an automatic level sludge collection in operation after the screen.

You told us that there is an Emergency bypass at the inlet and in the event of screen failure, the flows would overflow into a redundant tank which would then require a pump to return the flows to the inlet for screening.

After screening, the flows enter a second inlet channel which appeared clear of sewage debris during the inspection. The flows then drop into the wet well which you informed us had a low level and high level alarm, these would trigger if the flows backed up due to a pump failure.

The wet well contained two standby pumps, you told us that these were new pumps and were interstage/ intermediate pumps to maintain the flows and correct level within the wet well. You showed us that the MCERT flow meter is located here as permitted.

From the wet well the flows are pumped up to the primary settlement tank. You informed us that this tank requires recirculation pumps during the summer months as it can become septic. The tank contained an automatic de-sludge pump.

The flows weir over from the primary settlement tank into the syphon and then on to the media bed which is operated by motor driven sprinklers. The media beds appeared to have very little vegetation growing on the surface of the media. You said that this is inspected and maintained periodically to ensure they remain in good working order.

The flows then enter the final tanks which has an automatic de-sludge. The final effluent then flows through the permitted sample point.

There are two duty standby pumps installed at the outlet chamber which pumps out the final effluent intermittently. The telemetry was located within this chamber.

The STW has a permit to discharge treated Final Effluent at the consented discharge point SS 55370 86890 to the Coastal Waters of Oxwich Bay. We did not inspect the outfall on this occasion, however, we are aware that the outfall pipe is fractured in several places. This is resulting in final effluent being discharged into rockpools and onto the beach. This non-compliance is already being addressed in CAR\_NRW0041541. My understanding is that the outfall is due to be repaired in March/April 2025, weather depending,

We did not identify any non-compliances during the inspection of the works.
