This permit relates to an interceptor in the carpark of J Sainsbury PLC, Fabian Way, Swansea.

The permitted discharge point is a flap valve on the sea wall located on the right hand bank of the River Tawe, adjacent to the carpark. The point of discharge has been inspected from the opposite bank and showed no evidence of pollution at the time.
