4. Details of our assessment

A routine site inspection was undertaken on Friday 7th March 2025. This was the first inspection of the site since 9th February 2023.

No non-compliances were recorded in the previous inspection and on Friday 7th March 2025, the following observations were recorded:

Waste Storage & Management of Emissions

In the surrounding areas of the site, there did not appear to be any significant build-up of mud/debris and/or dust which could potentially emanate from site. Operations, and emissions from operations, were contained within the permitted area and site boundary.

All waste on site conformed with the list of permitted wastes in the Environmental Permit and processed waste was stored in various grades/types.

It is noted from the last inspection that waste is recovered in line with WRAP Quality Protocol. At the time of this inspection, this material appeared (visually) to comply with the requirements of this quality protocol. There was no visual contamination in this material which is now deemed 'non-waste'.

Waste Quality Protocol

It is likely that in a future inspection we will discuss waste quality protocol further and we may request that this treatment process is observed by officers.

The latest version of the site Environment Management System (EMS) we have on record is dated November 2021. If operations/procedures have changed since this date, please update the EMS and provide Natural Resources Wales with a copy.

At the time of the inspection, no non-compliances of the Environmental Permit were recorded and operations were assessed as being fully compliant with the permit.
