**4. Details of our assessment**

This CAR is to record a site visit made by NRW Officers to Lamby way closed landfill site and gas utilisation plant. NRW Officers Brigid Armstead and Mostyn Wall were escorted by representatives Infinis Energy for a tour around the gas utilisation plant.

The tour of the Lamby way closed landfill site is covered by a separate CAR.

Landfill gas is currently collected from Lamby Way South (LWS) and Lamby Way East (LWEE) and combusted in the gas control compound, either as fuel for the gas engines or by flaring. Landfill gas is delivered to the gas control compound via multiple head gas mains from across LWS and LWEE.

Gas utilisation takes place in the gas control compound, that on the date of the inspection contained 2 high temperature ground flares and 2 generators, one in use and the other as a back-up.

Compound inspections are carried out at least monthly by Infinis technicians during visits to the site for routine maintenance.

**Boosters:**

A slight gas odour was noticed around the gas pipework feeding into the boosters within the compound.

Action: There was an odour in the vicinity of the boosters. Please investigate this gas smell to confirm the origin and assess the risk posed by this.

**Gas****Flares:**

The flares appeared to be in good condition, with the telemetry in place to alert compliance team when any engine or flare is down. Quarterly checks are carried out to assess the pressure across flame arrestors.

**Gas****Engines:**

No non compliances were seen during the audit. One engine was running with no visible emissions or discolorations.

**General**

Spill kits were seen to be present and clean/ dirty oil was stored in a bunded facility.

This CAR was sent on 12.03.25 but is dated 3.10.24 as per the date of the site visit.
