4. Details of our assessment

Please note: This inspection concerns site operations only. No data audit was carried out as part of this inspection

I (Environment Officer Gavin Dodd) arrived at the CSO opposite Bowen Industrial Estate, Aberbargoed on Wednesday March 5th 2025 at 10:00 to conduct an inspection regarding a licence to operate a water discharge activity at the CSO mentioned above (Permit Number AN0334901). On the occasion of the visit, the weather was mild and dry.

The CSO was not discharging at the time of the visit and showed no indication of having

discharged recently. The receiving waterbody did not have an odour or any ragging present. Grid reference points were accurate to those provided on the permit for both the point of discharge and the monitoring point. No evidence of non-compliance.
